Faculty Dependents' Scholarship Plan -

Call for Applications

PREAMBLE

The Canadian Military Colleges Faculty Association supports post-secondary education and is committed to life-long learning. One way the Association demonstrates this is through a scholarship plan. This plan is open to immediate family members of Association members.

Every academic year, up to two (2) deserving students attending any accredited post-secondary institution will each be granted a scholarship of \$1,000.00.

TERMS AND ELIGIBILITY CRITERIA

- The applicants must be dependent children of Faculty Association members in good standing. "Dependent" means a child of an employee who is under 25 years of age at any point during the academic year in which a scholarship is to be held. The following will be considered children of the employee:
 - (i) persons to whom the employee is a biological parent or related to the employee through marriage or for whom the employee is the legal guardian;
 - (ii) stepchildren of the employee;
 - (iii) adopted children.
- Currently be accepted and registered as a full-time student at an accredited post-secondary institution.
- Have obtained a minimum overall average in their most recently completed full year of study of 75%.
 - o Provide official transcripts for high school and any post-secondary education. Photocopies or internet printouts are not acceptable.
- Have participated in extra-curricular activities in either school or community. A two-page essay describing this involvement is to be included with the application.
 - o Provide two letters of support or confirmation from the community group(s), coach(es) or individuals who have been the focus of the student's involvement.
- This scholarship is tenable with all other scholarships and bursaries.
- The application deadline is the last day of September in each year.
- The recipients may receive only one award in a lifetime.
- The awards will be paid to the recipients upon verification of enrolment and payment of tuition.
- A cheque for the amount of the scholarship will be issued to the student and mailed to the address provided on the application form.
- Scholarship recipients are issued T4A's in February for the previous taxation year.
- Awards will be announced at the CMCFA Executive Meeting. The winners will be notified immediately, and their names will then be posted on the CMCFA website. Official notification will be sent to all applicants.
